Is there anything wrong with clock hour programs?

- NO!
- Works great in schools with all PSAV / Clock hour programs
- Non mixed clock/credit hour environments
- Broward College has had clock hour programs for decades



Why move from clock hour to credit hour?

- Financial aid for students
 - Easier to administer / track
 - Reduce payment issues
- Can now get financial aid for both the technical courses and academic courses
- Puts the students in the mind-set to get their AS degree in Aviation Maintenance Management
- Marketing Perception
- No need for internal articulation agreements
 - Already had the credit course numbers in system
- Common language with advisors/counselors



What did we do?

- Worked with the Florida Department of Education to approve the new Educational Framework for the degree program
 - Now, all schools in the State of Florida can use the new Framework
- Also created a 31 credit avionics certificate program
- Got buy in of faculty and meet with all students
- Starting our second term of credit only classes this summer
 - We do not mix clock and credit made clean (quasi-painless) break
- Had to close out students who did not have enough hours for final financial aid disbursement under clock hours

What about the FAA?????

- What about them?
 - Did not change any of our course hour lengths
 - No changes to our manual
 - No changes to our curriculum
 - No changes in the delivery of the content



What about xxxxx??????

- What about teacher credentialing for SACS accreditation?
 - Most of our faculty have a bachelors degree already
 - Alternative credentialing method certificates and work experience
- What about teacher pay?
 - No change
 - 400 hours of instruction per term (3 terms per year)
- Other issues?
 - Placement testing



What's next?

- Standardize classes to 3 or 6 credits by combining classes
- Developing a complete AS degree for Avionics
- Building a 12,000 s/f hanger
- All of our aviation degrees now feed our Bachelors of Science Degree in Aerospace Sciences
